Registration conditions:

Parties agree as follows:

1. The definitions set out in Article 1 of the Regulations for Registration of .nl domain names shall apply to this Registration Contract.
2. The Parties enter into this Registration Contract with respect to the requested Domain Name.
3. The Applicant for a Domain Name declares that Applicant has taken cognisance of the Regulations for Registration of .nl domain names and that Applicant undertakes to abide by those Regulations.
4. The Applicant for a Domain Name undertakes that the information Applicant has provided in this registration contract is correct and complete and also that Applicant shall ensure, during the period of registration of the requested Domain Name, that changes in these details are forwarded to SIDN via Applicant's Participant without delay.
- 5.1 The Applicant for a Domain Name undertakes that Applicant is entitled to make use of the requested Domain Name.
- 5.2 The Applicant for a Domain Name declares that, to the best of Applicant's knowledge, Applicant is not infringing the rights of any third party by registering and later perhaps using the requested Domain Name.
6. The Applicant for a Domain Name accepts that any dispute regarding the Domain Name for which application is made shall be subject to Dutch law.
7. The Applicant for a Domain Name declares in advance that Applicant shall submit to the judgment rendered by the Domain Name Arbitration Tribunal should any third party submit a dispute regarding the Domain Name for which application has been made to the said Tribunal.
8. The Applicant for a Domain Name declares in advance that Applicant shall submit to the judgment rendered by the competent Dutch court should any third party institute legal proceedings regarding a dispute with respect to the Domain Name for which application has been made.
9. The Applicant for a Domain Name holds SIDN, the management and staff of SIDN, and all Participants harmless, and will indemnify them, with respect to all costs and damages arising for any of them from any claim by any third party that the registration and/or use of the requested Domain Name infringes that third party's rights.
10. Should the requested Domain Name have been requested in the manner prescribed in the Regulations for Registration of .nl domain names, SIDN shall include it in the Register and retain it in the Register. After the Domain Name has been included in the Register, SIDN shall include it in the .nl zone file.
11. The person signing this Registration Contract on behalf of the Applicant for a Domain Name declares that Applicant is authorised to request the requested Domain Name on behalf of the Applicant for a Domain Name.
12. The Applicant for a Domain Name declares that Applicant is represented by the Administrative Contact Applicant has indicated. The Applicant also declares that notifications directed to the Administrative Contact via the Admin-C e-mail address shall be deemed to have reached Applicant.
13. Amendments to this document shall only be valid if and when explicitly accepted by both Parties.
14. This Contract shall terminate in the cases provided for in the Regulations for Registration.

The data the domain name Applicant submits on the basis of this registration contract are recorded in the Domain Name and Personal Domain Name Register (the Register). In accordance with the Personal Data Protection Act the processing of this record has been reported to the Personal Data Protection Board under number M1051464.
